

Boggs Township Board of Supervisors

Regular Meeting
May 7, 2024

The May 7, 2024 regular meeting of the Boggs Township Board of Supervisors was held in the Boggs Township Municipal Building, 1270 Runville Road, Bellefonte, PA. Meeting called to order at 7:00 pm. The Pledge of Allegiance was observed. Present were Supervisors David Veneziano, Terry Gates, and Scott Bennett, Solicitor Rodney Beard, and Zoning Officer/UCC Administrator Jeff Williams.

Public Comment:

1. Zach Gay – Motion by Gates 2nd by Veneziano to sign the Non building Sewage wavier for the Frederick and Karen Moore Sub-division in Union and Boggs Townships.

Motion by Gates 2nd by Veneziano to send the Municipal Response Request for the Frederick and Karen Moore Sub-division back to Centre County Planning and Development Office with No Comments.

2. Bob Bennett – When will the office floor be installed? The installation date is May 13, 2024. Are the junk properties being cleaned up? Solicitor Beard explained that it is a slow process, but one property had been cleaned up in April 2024.
3. Vicki & Ralph Catherman – They asked why the Magistrate Filing takes so long? Solicitor Beard explained about preparing for the hearing by gathering evidence to minimize objections. Mrs. Catherman also informed us that a large piece of glass is in the stream at the Packer property.
4. Phil McKinley – Who is the code officer for the township? Jeff Williams is the code officer for Boggs Township.

Zoning Officer – Jeff Williams presented report for April 2024. He commented that activity has increased in the month of April.

Roadmaster – David Veneziano reported the road crew cleaned up after larger rain storms. We graded shoulders on several roads, cut trees, washed bridges, and cleaned ditches.

Oversite Committee – Terry Gates reported Engine/Rescue truck is still out of service. Mail Fund Raiser Drive has collected \$13,000.00 in the first month. Milesburg Borough is not cutting grass at the Fire Station, Fire Company is paying to have the grass cut. The Fire Company is working with an engineer to possibly modify the building to accommodate larger vehicles and potentially use a grant to fund the modifications.

Solicitor – Rodney Beard reviewed deed and plot plans for the Swampoodle Cemetery. He is recommending that we not get involved with the driveway pipe installation. He thinks that Broadband Service Maps should be reviewed for Boggs Township. Township secretary will check with Liz Lose at Centre County Planning and Development Office for assistance.


